

# **Summit Futbol Club**

## 2019-20 Player & Parent/Guardian Agreement

Participants & Parents/Guardians Agreement to Accept & Abide by the Rules of the Program Players and parents/guardians participating in Summit Futbol Club (SFC) are exercising a privilege afforded to them as registered members of US Soccer, the United States Youth Soccer Association (USYSA), the Vermont Soccer Association (VSA) and SFC. Players and parents or guardians are expected to conduct themselves in a manner that positively represents their team, the club and all affiliated organizations. The guidelines/rules below apply to all activities associated with your participation in SFC.

### I. General Guidelines:

- Players and parents/guardians are expected at all times to conduct themselves in a positive manner as outlined by the USYSA and VSA so as not to bring discredit upon SFC.
- When traveling with SFC, players and parents/guardians are expected to conduct themselves in a manner that positively represents SFC, its' players and administration.
- Respect for the property of others, adherence to the rules and guidelines specified in this document or outlined by the coach/administrator, and observance of State and Federal laws are required in order to participate in SFC.
- All players & parents/guardians are expected to fulfill the expectations of SFC regarding communicating in a timely manner with coaches and club personnel regarding attendance at scheduled training sessions, scrimmages, games, tournaments and or club meetings.
- Players and parents/guardians of SFC are expected to behave in a positive and supportive manner towards their team, its' coaches and players at all times. They shall refrain from negative and derogatory language directed towards opponents, their supporters, coaches/club officials and referees.
- Players and parents/guardians are required to ask and get permission from their team coach or the Technical Director prior to "agreeing to" or "guesting" with any other team for training, games, tournaments or events.
- Failure to pay club fees in a timely fashion will result in the participating player being held out of training and or competitions until payment is made.
- If issues/concerns arise during the training and or competitive season, players/parents/guardians are expected to address them in a timely manner with their team coach. If a solution cannot be found, then the team coach will consult the Technical Director, and if necessary the President for assistance.

## II. <u>Disciplinary Rules</u>:

- The use/or possession of drugs, alcohol and/or tobacco products including e-cigarettes, vaping or "juuling" by players while representing SFC, including traveling to and from games or events, is cause for disciplinary action. Consumption of alcoholic beverages by parents/guardians at game or practice sites is prohibited. All must adhere to the non-smoking regulations at SFC facilities and all outside competition sites.
- Persistent irresponsible and disrespectful behavior directed towards opponents, their supporters and coaches/club officials or referees is cause for dismissal from SFC.
- Destruction of property/violation of State & Federal laws is cause for dismissal from SFC.
- Players receiving fines for red cards, fighting, dissent as well as yellow card accumulation are financially responsible for such fines and are subject to additional discipline by SFC.
- Failure to comply with club or individual team rules (curfew, attendance, dress code, schedule, etc.) is cause for disciplinary action including dismissal from SFC.
- Bullying in any form will not be tolerated and the offender(s) are subject to suspension/dismissal from SFC.

- Persistent failure to adhere to the above guidelines/rules is cause for dismissal from SFC for the remainder of the current season and could affect a player's future participation.
- All annual fees are forfeited in the event of dismissal from Summit FC.

Note: If suspension or dismissal from SFC occurs while traveling, the offending player(s) may be sent home immediately at the expense of the player/parent/guardian, by whatever means are most convenient for SFC, its' coaches and or administration. No reimbursement of program fees will be made.
